- We have provided service to the American Indian Community for 74 years and will celebrate 75 next year
- We are the oldest urban Indian Center in the United States
 - Originally, we provided a location for American Indians to gather, wash & clean, sell their wares and receive job search assistance
- We continue to grow and expand our programs and services to meet the needs of the community



Navigation Services

SNAP Application Assistance

- Assist with application completion for SNAP benefits
 - Due to the pandemic, we are offering assistance virtually
- Submit application & verification documents to DES
- Food Box Referrals



- Assist individuals facing immediate emergency needs
 - Rental & Utility Assistance, when we have funding
 - If no resources in-house, referrals to community agencies are provided
- Information & Referral
- Document completion
 - Unemployment, self-service legal papers, SSDI, Vocational Services selfreferrals, other documents

Child Care

- Currently closed due to the pandemic
- Free and available to clients utilizing Center services
 - Children ages 5 and under
 - Clients must remain on 2nd floor



Youth Development Services

- Future Inspired Native American Leaders (F.I.N.A.L): College and Career Readiness
 - Open for any self identifying Native youth grades 9-12
 - Provides mentoring and coaching in 4 areas:
 - Culture
 - Prevention
 - Post-secondary
 - Career exploration
 - F.I.N.A.L.Youth Council
 - Youth Leadership Day



Youth Development Services

Youth to Work

- Pays high school Juniors/Seniors while they work
 - In Person must be fully vaccinated
 - Virtually approved businesses across Maricopa County
- Executed during December and July
 - December 2 weeks
 - July Up to 100 hours (usually 3 weeks)
- We are always looking for businesses to partner with to help provide our youth with experience in the workforce

Workforce Development

- Funded by the US Department of Labor Workforce Innovation and Opportunity Act (WIOA)
 - Clients must be an enrollment member of a federally recognized tribe, Alaskan Native, or Native Hawaiian to be eligible for program enrollment
- Assist and support clients in gaining employment
 - Provide training opportunities, when available, specific to client's goals
 - Work with clients to ensure they remain gainfully employed for 12 months
 - Assure clients obtain a job with a decent living wage



Workforce Development

We assist clients with job search by:

- Providing tools, resources & information to aide in job search
 - Share job leads
 - Provide job readiness workshops
- Provide on-going, individualized support from our Workforce Specialists
 - Assist clients with resumes and polish interview skills
 - Establish opportunities to develop new skills or work experience
 - Provide support services to eligible participants

Phoenix Indian Center – Maricopa County

- Native American Community Service Center's main lobby in entrance of building is open to the public
- Phoenix Indian's Center's office is closed to walk-ins
- All clients are contacted via phone calls and emails
- In-Person Services are strictly limited to those clients who cannot be serviced through virtual mediums
- All service areas are providing program activities virtually
- Outreach is conducted virtually with minimal in-person commitments
